Platinum Package

Any conflicts with other photographic or video coverage contracts, and any notifications necessary to avoid such conflicts, are the sole responsibility of the client.
2. Client assumes all responsibilities for obtaining any necessary permission, clearance permits, insurance, etc., which may be required for Arturo Cornejo (CINECUY – Cinematic Videos) to video record each event, public or private. Client assumes all responsibility for obtaining and retaining permission for access to any requested video camera positions and is solely responsible for the quality of the final production resulting from the use of, or inability to use such video camera positions.
3. The client warrants that he/she has the legal rights to anything Arturo Cornejo (CINECUY – Cinematic Videos) will video record; including photos, musical recordings, or any other materials delivered to Arturo Cornejo (CINECUY – Cinematic Videos) for inclusion in the client's master video.
4. The Client agrees to indemnify and hold Arturo Cornejo (CINECUY – Cinematic Videos) harmless for any loss, damage, or liability for infringement of any rights arising from the use or sale of any digital content that the client hires Arturo Cornejo (CINECUY – Cinematic Videos) to produce, edit, or duplicate.
5. Arturo Cornejo (CINECUY – Cinematic Videos) reserves the right to use these videos for display, publication or other purposes. All video masters and raw footage remain the exclusive property of Arturo Cornejo (CINECUY – Cinematic Videos).
6. The client reserves the right to terminate the contract for any reason at any time up to the date of the event. Should the client terminate the contract, all money paid less the retainer will be refunded.
7. The client has critically viewed samples of Arturo Cornejo (CINECUY – Cinematic Videos)'s video work and hereby grants full editorial and production control to Arturo Cornejo (CINECUY – Cinematic Videos), regarding all aspects of the production and post-production services for the event.
8. In the event a particular segment of the event is either not recorded, partially recorded, or not a part of the edited master video, it is at the sole discretion of Arturo Cornejo (CINECUY – Cinematic Videos) as the exclusive producer of the event video recording.
9. Changes requested to the final video master after delivery to the client are charged at a rate of \$100 an hour.



10. All personal property provided by the client to Arturo Cornejo (CINECUY – Cinematic Videos) for utilization in the post-production of their video is received by Arturo Cornejo (CINECUY – Cinematic Videos) at the complete and total risk of the client. Arturo Cornejo (CINECUY – Cinematic Videos) will make every effort to ensure the safekeeping of the client’s personal property while in its possession and return the same to the client upon the delivery of the edited master video.
11. If Arturo Cornejo (CINECUY – Cinematic Videos) fails to comply with the terms of this Agreement due to any event or at beyond the control of Arturo Cornejo (CINECUY – Cinematic Videos), including but not limited to illness, accident, labor disputes, acts of God and other catastrophes, or uncontrollable and unforeseeable equipment failure, Arturo Cornejo (CINECUY – Cinematic Videos)'s liability is limited only to a refund of all money received.
12. Arturo Cornejo (CINECUY – Cinematic Videos) produces Blu-ray and DVDs using the most compatible media for set-top players. Arturo Cornejo (CINECUY – Cinematic Videos) is not responsible for incompatibility with the Blu-ray or DVDs discs created and the client’s player.
13. Any liability on the part of Arturo Cornejo (CINECUY – Cinematic Videos) will be limited to the amount of money paid.
14. Finished Production will be stored in my database for a term of 1 year from the Wedding date. Changes can be made by request for an hourly fee.
